### An act for ye Puting in Execution ye Laws

of England in this Colony where no Provission be made by ye acts of this Colony

Bee it Enacted by ye authority aforesd yt where ye Laws of this Colony or Custom Shall not Keach or Comprehend any matte cause or Causes y' it Shall be Lawfull to put in Execution ye Law of England &c any act or acts to ye Contrary notwistanding

### [90] An act for ye Better Regulating ye Militia

& for Punishing offenders as Shall not Conform to ye Laws there unto Relating

Bee it Eneted by ye honble ye Gouerer Councill & house of Representatives in this Present Sessions assembled & by ye Authority thereof it is hereby Enacted y' after ye Publication of this Act y' if any person or persons Listed Under ye Comand of any Cap' or Commader in Cheif of ye Militia Shall or do not appear Compleat in armes (Viz") wth A Good & Sufficient muskett or Fuze a Sword or Bayenet, Catooch box or Bandelers wth twelve Bulets fitt for his Peice half a Pound of Powder & Six good Flints Upon ye Precise Training Days already prefixt as well as when there Rspective Capts or Comanders in Cheif Shall call them Togeather Either by Allarum or any other time or times as Shall by their st Commanders be thought fitt & Expedient for his majties Interest During ye Times of Warr & if any person or persons Listed &c Shall neglect their Respective Dutys & due Obedience & not appear in Manner Afores Shall forfiet for Each neglect on ye Days Appointed for Training or Other Meetings in Armes ye Sum of Thre Shillings in money wth ye Due Fees Arifing thereon & for non Appearance or neglect on any Larum ye Sum of five Shilling wth ye Due Fees Arifeing thereon to be taken by Distraint or otherwise as ye fines for non apperance on ye Training Days are to be Taken

And it Is Further Enacted by The Authority Aforesaid

That all persons win this Colony Above ye Age of Sixteen Years & Under ye Age of Sixteen yeares as well housekeepers as others Shall be Obliged to watch or ward or find or procure A Sufficient man to watch or ward Upon Legall Notice given to any of them by yo Capt or Comander in Cheif to watch [91] & by ye Gover Depty Gover afsifts Consevaters & Wardens of ye Respective Towns to ward ye warders to be Such persons as are not in ye Capt Lift & yt ye sd persons Appointed to watch do at all times & upon all occations Observe & Follow Such Orders & Instructions as they Shall from time to time Receive from their Respective head officers as afores<sup>d</sup> & if any p<sup>er</sup>son Shall refuse or Neglect to watch & Follow Such ord<sup>ers</sup> as Upon Legall Notice given as afores<sup>d</sup> he or they so Neglecting or Refuseing Shall pay as a fine ye Sum of five Shillings in money to be taken or Imprisoned in manner & form as ye fines for neglect or training or Allarums are Taken & Provided in

And it is Further Enacted by yo Authority aforesd That all housekeepers as well widdows as others allthough there be no person in sd Family yt is Qualified According to Law as to watching & warding Yett never ye less it Shall be in ye pow & Authority of ye Capts Comander or head Officers as Aforesd at thei Discression to Order ye sd housekeepers to find a Sufficient water or warder or to pay so much money as will Hire or procure on & upon Neglect or Refusall thereof to be under ye Like fine & Penaty as those

That all fines & forfictures y' Shall Arife upon persons neglecting in training & Watching Shall be disposed of by y Comission officer off Each Respective Company to Provide Drums Colours & Amunition &c

And ye fines y' Shall be from ye warders to be Disposed by the Goverer & assistants for Repairing of ward houses or other Conueniences for his Majites Seruice

## An act For stateing of Fees in all Actions

Determinable before the Goverer Deputy Goverer Assistant Iustices Confervators or Wardens &c of ye Sever" Towns in this Colony

Bee it Enacted by ye Goverer Coun" & Representatives & ye Authority [93] thereof & it is therefore Enacted That the Goverer Depty Goverer afsift's Iustices of ye Peace Conservaters or wardens of their Respective towns Shall by Uertue of this Act have as Fees or Bill of Cost in all Actions not Exceeding forty Shilling Determinable & to be Determined before them from all persons Either Plant's or Defend's & y' on their Respective Cases Sentance or Judgment Dothe by ye Authority afores' pass against Vizt for A warrant or writt one Shilling for Each Summons or Evidence in sa Cafe one Shilling for Iudgment two shillings for bond for ye Peace or good Behauor two Shillings & Sixpence & Be it Further Enacted That Every Conflable win this Colony in all Actional Cafes of Meum & Tuum Shall have for Serveing Each Writte one Shilling all ways Provided ye sd persons so Complaind of if Judgment Shall pass against him or if Iudgm' Shall pass Against ye Plat if ye person Arested Shall live above one mile distance from ye Constable then ye Constable to have aboves one Shilling & two pence & mile forth & Back & ye Constable to have for Sumonsing each person
